WHEREAS, the Village engaged Kimley-Horn Engineering and Landscape Architecture of New York, P.C. to perform a Traffic Signal Warrant Study and Intersection Evaluation for the intersection of North Main Street (NY Route 94/17A) & Farries Avenue; and

WHEREAS, by report dated August 2024, Kimley-Horn concluded that existing traffic volumes satisfies the 4-hour and peak-hour warrant volume and that it is anticipated additional development would result in unacceptable operation of the Farries Avenue approach by 2034;

WHEREAS, the Study recommended that a traffic light be installed at the intersection of Farries Avenue and North Main Street; and

WHEREAS, the Study has been referred to the New York State Department of Transportation because North Main Street is a New York State highway; and NOW THEREFORE, BE IT RESOLVED, the Village Board of the Village of Florida hereby adopts a resolution supporting the installation of a traffic light and other appropriate pedestrian signals at the intersection of North Main Street and Farries Avenue; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be transmitted to the NYS Department of Transportation, Town of Warwick, Florida Union Free School District, Assemblyman Karl Brabenec and State Senator James Skoufis.

WHEREAS, the Village of Florida received a proposal from TAM Enterprises to supply and install a new insulated cover for the Beazer pump station as the existing cover no longer functions in a sufficient manner to allow one to open the lid to the pump for the sum of \$ 12,390.00; and

WHEREAS, the sole source for the lid is the pump station manufacturer;

WHEREAS, the repair is time sensitive as the Village needs to have the ability to access the pump station quickly;

NOW THEREFORE BE IT RESOLVED, that the Village Board hereby accepts the proposal of TAM Enterprises not to exceed \$ 12,390.00; and

BE IT FURTHER RESOLVED that to the extent the Village of Florida Procurement Policy requires obtaining multiple bids, the Village Board finds that the instant procurement is on an emergency basis and further finds that the lid is a sole source item and obtaining further quotes will not be beneficial to the Village of Florida.

#### 5. Bond Resolution Water Plant

Attorney Cassidy gives a brief explanation for the need for this resolution and explaining that the original estimate is on track and total costs have increased, does not mean that we are spending more, that is what EFC has documented between our contingencies we still remain on track for our original documents previously approved. EFC are asking to amend original resolution to include higher amount as contingency which enables us if there is a small overage, we have the ability to finance that above and beyond \$5,290,000.00. This is not the bond itself but includes the \$3,000,000.00 grant previously administered.

RESOLUTION OF THE VILLAGE OF FLORIDA, NEW YORK, ADOPTED JANUARY 15, 2025, AMENDING THE BOND RESOLUTION ADOPTED ON SEPTEMBER 9, 2019, RELATING TO THE CONSTRUCTION OF IMPROVEMENTS TO THE VILLAGE WATER TREATMENT PLANT AND DISTRIBUTION SYSTEM

#### Recitals

WHEREAS, the Board of Trustees of the Village of Florida, in the County of Orange, New York, has heretofore duly authorized the construction of improvements to the Village water treatment plant and distribution system at the estimated maximum cost of \$5,290,000 pursuant to the bond resolution adopted by the Board of Trustees on September 9, 2019; and

WHEREAS, the estimated maximum cost of said project has now been determined to be \$8,054,215, and it is necessary and in the public interest to increase the amount appropriated for said project by \$2,764,215 and to amend said bond resolution to increase the principal amount of bonds authorized from \$5,290,000 to \$8,054,215;

Now, therefore, be it

RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF FLORIDA, IN THE COUNTY OF ORANGE, NEW YORK (by the favorable vote of not less than two-thirds of all members of said Board of Trustees) AS FOLLOWS:

Section (A) The bond resolution of the Village of Florida duly adopted by the Board of Trustees on September 9, 2019, entitled:

"Bond Resolution of the Village of Florida, New York, adopted September 9, 2019, authorizing the construction of improvements to the Village water treatment plant and distribution system, stating the estimated maximum

cost thereof is \$5,290,000, appropriating said amount for such purpose, and authorizing the issuance of bonds in the principal amount of not to exceed \$5,290,000 to finance said appropriation,"

is hereby amended to read as follows:

BOND RESOLUTION OF THE VILLAGE OF FLORIDA, NEW YORK, ADOPTED SEPTEMBER 9, 2019 AND AMENDED JANUARY 15, 2025, AUTHORIZING THE ISSUANCE OF BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$8,054,215 TO FINANCE THE CONSTRUCTION OF IMPROVEMENTS TO THE VILLAGE WATER TREATMENT PLANT AND DISTRIBUTION SYSTEM, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$8,054,215 AND APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE

THE BOARD OF TRUSTEES OF THE VILLAGE OF FLORIDA, IN THE COUNTY OF ORANGE, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Board of Trustees) AS FOLLOWS:

Section 1. The Village of Florida, in the County of Orange, New York (herein called the "Village"), is hereby authorized to issue bonds in a principal amount not to exceed \$8,054,215 pursuant to the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called the "Law"), to finance the construction improvements to the Village water treatment plant and distribution system, substantially as described in the engineer's report dated September 2021 and revised November 2021 prepared by Pitingaro & Doetsch Consulting Engineers, P.C.

Section 2. The estimated maximum cost of the project described herein, including preliminary costs and costs incidental thereto and the financing thereof, is \$8,054,215 and said amount is hereby appropriated for such purpose. The plan of financing includes the issuance of bonds in the principal amount of not to exceed \$8,054,215 to finance said appropriation. Water charges have been imposed in the Village and it is expected that such charges shall continue to be imposed and collected by the Village and the amounts derived therefrom shall be budgeted and used to the pay principal of and interest on the bonds, and any notes issued in anticipation thereof, as the same shall become due and payable. It is expected that grant funds may be received in relation to the project, and any such funds received or to be received are hereby authorized to be applied toward the cost of said project or redemption of the Village's bonds or

notes issued therefor, or to be budgeted as an offset to the taxes to be collected for the payment of the principal of and interest on said bonds or notes.

Section 3. The following additional matters are hereby determined and declared:

- (a) The period of probable usefulness applicable to the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 1 of the Law, is forty (40) years.
- (b) The proceeds of the bonds herein authorized, and any bond anticipation notes issued in anticipation of said bonds, may be applied to reimburse the Village for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.
- (c) The proposed maturity of the bonds authorized by this resolution will exceed five (5) years.

Section 4. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the Village, payable as to both principal and interest by general tax upon all the taxable real property within the Village. The faith and credit of the Village are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the Village by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 5. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 of the Law relative to the authorization of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation

notes and Section 50.00 and Sections 56.00 to 60.00 and Section 168.00 of the Law, the powers and duties of the Board of Trustees relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, and as to executing agreements for credit enhancement, are hereby delegated to the Village Treasurer, the chief fiscal officer of the Village.

Section 6. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the Village is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 7. This bond resolution is subject to a permissive referendum and the Village Clerk is hereby authorized and directed, within ten (10) days after the adoption of this resolution, to publish or cause to be published, in full, in the official newspaper of the Village, having a general circulation within said Village, and posted in at least six (6) public places and in each polling place in the Village, a Notice in substantially the form appearing in Exhibit A hereto.

Section 8. The Village Clerk is hereby authorized and directed, after said bond resolution shall take effect, to cause said bond resolution to be published, in summary, in the official newspaper of the Village, having a general circulation within said Village, together with a Notice in substantially the form as provided by Section 81.00 of the Law.

Section (B) The amendment of the bond resolution as set forth in Section (A) of this resolution shall in no way affect the validity of any liabilities incurred, obligations issued, or action taken pursuant to said bond resolution prior to amendment, and all such liabilities incurred, obligations issued, or action taken shall be deemed to have been incurred, issued or taken pursuant to said bond resolution, as amended.

Section (C) Said bond resolution, as amended, is subject to a permissive referendum as therein provided. In the event that a valid petition protesting against said bond resolution and requesting that it be submitted to the electors of said Village for their approval or disapproval is filed and the Proposition submitted therefor is defeated, the validity of the bond resolution adopted on September 9, 2019, shall not be in any way affected and shall remain in full force and effect.
